

Eligibility Determinations



- Services/supports for individuals with Developmental Disabilities are managed through the County MH/ID Program
 - Based on the Mental Health/Intellectual Disabilities Act of 1966
- Eligibility is determined by the County Program for both the County ID Program and for ODP's Waiver Programs
 - Eligibility for County funded services is limited to individuals with Intellectual Disabilities
 - Information on Intake can be obtained by contacting the Bucks County Department of Mental Health/Developmental Program
 - 215-444-2800 Ask to speak with the Intake person



The County MH/ID/DD Program determines whether individuals meet the following waiver eligibility criteria:

- Diagnosis of one of the following:
 - Intellectual disability
 - Autism
 - Developmental disability with a high probability of resulting in an intellectual disability or autism – Age 0 through age 8
- Level of Care for ICF/ID or ICF/ORC
- Emergency PUNS or reserved capacity
- Need for at least 1 waiver service in addition to Supports Coordination
- Financial requirements for waiver eligibility



DD Children 8 and Younger

The child :

- must have a diagnosis of a developmental disability, which is defined as a condition of substantial developmental delay or specific congenital or acquired conditions with a high probability of resulting in an intellectual disability or autism spectrum disorder, the disability manifested prior to the age of 9 and the disability is likely to continue indefinitely;
- is 8 years of age or younger;
- must have substantial adaptive skill deficits in three or more areas of major life activity based on a standardized adaptive functioning test; and must be recommended for an ICF/ORC level of care based on a medical evaluation.

ID Diagnosis

Core requirements

 Cognitive Deficits, Adaptive Deficits, medical recommendation for ICF/ID LOC and occurred during the developmental period

Cognitive

- Performance that is more than two standard deviations below the mean of a standardized general intelligence test, which
 reflects a Full Scale IQ score of 70 or below, or
- Performance that is slightly above two standard deviations below the mean of a standardized general intelligence test during a period when the individual manifests serious impairments of adaptive functioning.

Adaptive Limitations

- must have substantial adaptive skill deficits in three or more areas of major life activity based on a standardized adaptive functioning test;
 - Vineland
 - Adaptive Behavior Assessment Scale (ABAS)
- Must be recommended for an ICF/ID level of care based on a medical evaluation.
- Developmental Period prior to age 22



ASD Eligibility

- Diagnosis is ground in diagnostic tool (s) and made by a qualified professional
 - Formal assessments
 - Clinical Interviews
 - Rating Scales
 - Previous records
 - Self-Report
- Substantial Functional Limitations
 - must have substantial adaptive skill deficits in three or more areas of major life activity based on a standardized adaptive functioning test;
 - Vineland
 - Adaptive Behavior Assessment Scale (ABAS)
- Must be recommended for an ICF/ORC level of care based on a medical evaluation.




